CONGRADULATIONS ON “COMMITING” TO BECOME AN OFFICIAL MEMBER/EMPLOYEE OF JUMPSTART ENTERTAINMENT, LLC.

YOU WILL FIND THAT, EVEN THOUGH IT IS A LONG PROCESS, IT IS WELL WORTH THE HARD WORK AND DEDICATION REQUIRED AND EXPECTED. WE ARE PROUD TO BE A WELL SUCCESSFUL, FAMILY-ORIENTED BUSINESS.

BELOW IS THE OFFICIAL PROCESS FOR A PROSPECTIVE, NEW MEMBER TO ENTER INTO JUMPSTART ENTERTAINMENT, LLC AND BECOME AN OFFICIAL MEMBER/EMPLOYEE HOLDING CLASS C MEMBERSHIP INTEREST.

1. **OBSERVE!** ATTEND SEVERAL JSE AND NON-JSE EVENTS, OBSERVING HOW THE EVENT IS CONDUCTED, HOW THE MEMBERS INTERACT WITH THE CROWD (AUDIENCE), AND HOW THE GENERAL ENVIRONMENT AND ENERGY IS FELT. HOW THE PROMOTER(S) INTERACT, HOW THE DJ(S) PLAY AND RUN THE CROWD (AUDIENCE), HOW THE MC(S) ON THE MICROPHONE ENERGIZE THE CROWD (AUDIENCE), HOW THE DIVA(S) CONDUCT THEMSELVES. WATCH VARIOUS ENTERTAINMENT COMPANIES.
2. **DECIDE!** MAKE A SOLID DECISION THAT JUMPSTART ENTERTAINMENT, LLC IS THE FAMILY-ORIENTED COMPANY THAT WOULD BEST SUIT YOU. ASK YOURSELF, DO YOU FEEL YOU WOULD BE A VALUABLE ASSET TO JUMPSTART ENTERTAINMENT, LLC?
3. **MAKE CONTACT WITH SPONSOR!** APPROACH ONE OF THE OFFICIAL MEMBERS TO “VOUCH/SPONSOR” YOU IN. THIS SHOULD BE THE ONE OFFICIAL MEMBER IN JUMPSTART ENTERTAINMENT, LLC THAT KNOWS YOU BEST AND CAN/WILL SPEAK ON YOUR BEHALF TO THE COMPANY. THIS OFFICIAL MEMBER WILL BE IN THE SAME DEPARTMENTAL POSTION AS THE ONE YOU ARE APPLYING FOR, (DJ FOR DJ, PROMOTER FOR PROMOTER, DIVA FOR DIVA, MC FOR MC).THIS OFFICIAL MEMBER WILL WALK YOU THROUGH THE PROCESS STEP-BY-STEP, AND PROVIDE YOU ALL THE NECESSARY DOCUMENTS. THIS OFFICIAL MEMBER IS RESPONSIBLE FOR YOU AND YOUR CONDUCT DURING YOUR “PROBATION/PROSPECTIVE PERIOD” AND CAN, AT ANY TIME, WITHDRAWL HIS/HER SPONSORSHIP OF YOU, HAULTING YOUR PROCESS.
4. **JSE PRE-APPLICATION!** FILL OUT, PRINT AND SIGN (ALONG WITH YOUR SPONSOR) THE “JSE PRE-APPLICATION” FORM. PUT SPECIAL EMPHASIS ON THE “WHY DO YOU WANT TO JOIN JSE/WHAT DO YOU FEEL YOU CAN BRING TO JSE?” QUESTION AS THAT WILL BE A DECIDING FACTOR IN THE VOTE TO ALLOW YOU TO **COMMIT** AT THE NEXT JSE MEETING.

5. **1ST JSE MEETING!** YOUR SPONSOR WILL INVITE YOU TO THE NEXT JSE MEETING. AT THE MEETING, YOUR SPONSOR WILL PRESENT/INTRODUCE YOU TO ALL MEMBERS IN ATTENDANCE THAT YOU DON'T ALREADY KNOW. AFTER REGULAR BUSINESS IS DISCUSSED, YOU AND YOUR SPONSOR WILL BE ASKED TO STAND UP AND ASKED VARIOUS QUESTIONS BY THE MEMBERS. FINALLY, YOU WILL BE ASKED TO LEAVE THE IMMEDIATE AREA WHILE MEMBERS ASK YOUR SPONSOR QUESTIONS THEN FINALLY CONDUCT A BLIND-VOTE ON WHETHER TO ACCEPT YOUR APPLICATION TO COMMIT TO JSE OR NOT. IF DISAPPROVED, YOUR SPONSOR WILL PROVIDE YOU WITH DETAILS AND LEAD YOU ON THE PATH TO BE APPROVED. IF APPROVED, YOU WILL BE PROVIDED A "NEW MEMBER CHECKLIST" AND THUS **START YOUR OFFICIAL "PROBATION/PROSPECTIVE" PERIOD, USUALLY 6 MONTHS FROM THIS DATE.**
6. **ATTEND/PROMOTE JSE EVENTS!** YOU WILL BE IMMEDIATELY EXPECTED TO HELP IN THE PROMOTION OF ALL JSE EVENTS (EVEN IF NOT IN PROMOTION POSITION) VIA ALL MEANS NECESSARY (INTERNET SOCIAL SITES, FLYERS, TEXT MESSAGES, WORD OF MOUTH, ETC). YOU WILL BE EXPECTED TO ATTEND **90%** OF ALL JSE EVENTS. YOUR SPONSOR WILL PROVIDE YOU A MINI-LOG BOOK TO HAVE 2 JSE OFFICIAL MEMBERS SIGN **EACH** TIME YOU ATTEND A JSE EVENT, TO BE REVIEWED AT EACH MEETING.
7. **ATTEND POSITIONAL MEETING!** YOU WILL BE EXPECTED TO ATTEND ANY AND ALL DEPARTMENTAL POSITION MEETINGS HELD FOR THE POSITION YOU APPLIED FOR (DJ SCRATCH SESSIONS, PROMOTERS ONLY MEET-UP, MC'S MEETING, DIVAS ONLY). YOUR SPONSOR WILL PROVIDE YOU WITH ALL JSE DOCUMENTS/FORMS TO BE COMPLETED AND SUBMITTED ON THE 2ND JSE MEETING.
8. **2ND JSE MEETING!** YOUR SPONSOR WILL GIVE YOU YOUR "PROSPECTIVE JSE MEMBER" PASS AND SHIRT(S) AND YOU WILL BE EXPECTED TO WEAR IT AT ALL JSE/NON-JSE EVENTS, MEETINGS, ETC. ALL YOUR FILLED IN JSE DOCUMENTS WILL BE DUE AND SUBMITTED BY YOUR SPONSOR TO BE FILED IN YOUR MEMBER EMPLOYEE JACKET. YOU WILL BE GIVEN THE TASK OF HOSTING/ORGANIZING/COORDINATING/PROMOTING A SUCCESSFUL JSE EVENT TO BE HELD NO LATER THEN THE 6TH JSE MEETING. YOUR SPONSOR WILL BE AVAILABLE TO ASSIST YOU IF YOU HAVE ANY QUESTIONS OR NEED HELP. YOU WILL BE GIVEN A COPY OF THE JUMPSTART ENTERTAINMENT, LLC BYLAWS AND WILL BE GIVEN A 30 QUESTION QUIZ AT THE NEXT JSE MEETING.
9. **3RD JSE MEETING!** YOU WILL BE GIVEN YOUR JUMPSTART ENTERTAINMENT, LLC BYLAWS 30 QUESTION QUIZ. IF FAIL YOU WILL BE GIVEN THE OPTION TO RE-TAKE PRIOR TO THE NEXT JSE MEETING.
10. **POSTED ON WEBSITE!** AFTER YOUR HALFWAY MARK OF 3 MONTHS. WEBMASTER WILL POST YOU ON THE OFFICIAL JSE WEBSITE. YOU WILL STILL HAVE THE "PROSPECTIVE" TITLE ATTACHED TO IT UNTIL YOU ARE VOTED AS AN OFFICAL MEMBER.
11. **4TH JSE MEETING!** YOU WILL BE GIVEN A COPY OF THE JUMPSTART ENTERTAINMENT, LLC OPERATING AGREEMENT AND WILL BE GIVEN A 30 QUESTION QUIZ AT THE NEXT JSE MEETING. YOU WILL GIVE STATUS (INCLUDING DATE/TIME/LOCATION/THEME/DJ) OF YOUR PLANNED JSE EVENT TO MEMBERS, IF NOT COMPLETED ALREADY. JSE MEMBERS WILL HELP PROMOTE AT YOUR LEAD.

- 12. **HOST JSE EVENT!** THE PREFERABLE TIME FRAME FOR YOUR JSE EVENT SHOULD BE BETWEEN THE 4TH AND 5TH JSE MEETING BUT CAN BE COMPLETED NO LATER THEN THE 6TH JSE MEETING.
- 13. **5TH JSE MEETING!** YOU WILL BE GIVEN YOUR JUMPSTART ENTERTAINMENT, LLC OPERATING AGREEMENT 30 QUESTION QUIZ. IF FAIL YOU WILL BE GIVEN THE OPTION TO RE-TAKE PRIOR TO THE NEXT JSE MEETING. YOU WILL BE GIVEN INFORMATION ON YOUR UPCOMING INITIATION AND FINAL VOTE @ 6TH JSE MEETING. A COMPLETE REVIEW OF YOUR "JSE NEW MEMBER CHECK-OFF LIST "WILL BE CONDUCTED TO ENSURE YOU WILL BE READY FOR INITIATION/FINAL VOTE.
- 14. **6TH JSE MEETING!** YOUR SPONSOR WILL PRESENT YOU TO JSE MEMBERS ALONG WITH A COMPLETED "JSE NEW MEMBER CHECK-OFF LIST". YOU WILL BE ASKED TO STAND AND ASKED VARIOUS QUESTIONS. YOU WILL BE ASKED TO LEAVE THE IMMEDIATE AREA WHILE MEMBERS ASK YOUR SPONSOR QUESTIONS THEN FINALLY CONDUCT A BLIND-VOTE ON WETHER TO ACCEPT YOUR APPLICATION FOR OFFICIAL MEMBERSHIP/EMPLOYMENT IN JUMPSTART ENTERTAINMENT, LLC OR NOT. IF DISAPPROVED, YOUR SPONSOR WILL PROVIDE YOU WITH DETAILS AND LEAD YOU ON THE PATH TO BE APPROVED. IF APPORVED, YOU WILL BE GIVEN A PLEDGE OF LOYALTY FORM TO SIGN, ACCEPTANCE OF COMPANY PASS FORM, AND ACCEPTANCE OF CLASS C MEMBERSHIP AGREEMENT.
- 15. **JSE DINNER!** YOU WILL BE PROVIDED OF A LOCATION/TIME OF A JSE DINNER IN YOUR HONOR. YOUR SPONSOR WILL PICK YOU UP. THERE YOU WILL CELEBRATE ON BECOMING A NEW JSE MEMBER (ASSUMING YOU PASS YOUR INITIATION).
- 16. **JSE INITIATION!** THAT NIGHT, AFTER THE DINNER, YOU WILL PROCEED WITH THE JSE INITIATION. IT WILL BE HELD AT EITHER A JSE NIGHT CLUB OR JSE PARTY. AFTER INITIATION, YOU WILL BE PROVIDED WITH YOUR "OFFICIAL JSE PASS" BY YOUR SPONSOR AND TAKE SEVERAL CONGADULATORY PICTURES WITH JSE/NON-JSE MEMBERS. YOU ARE NOW AN OFFICIAL MEMBER OF JUMPSTART ENTERTAINMENT, LLC! A FAMILY-ORIENTED BUSINESS. REPRESENT!
